SPORT Commission to re-appraise the NSC

THE scope and composition of the National Sports Council will be re-appraised by the Commission of Enquiry into all Major Sports, which will begin their public sittings on Fridayat 1.00 p.m. at the Town Hall.

This was revealed by Joe Goddard, a former National Olympic sprinter and a member of the commission at a Press Conference at' White Hall on Monday.

At that stage Mr Justice Ralph Narine, the chairman of the Commission had asked Goddard to elaborate on a

question put by the Press.

"Yes," said the exsprinter now an airline official, "We have a lot of work to do researching the National Sports Council and the Trinidad and Tobago Olympic Association.

"We are particularly interested to find out"Goddard said, "whether the formula of administrating sport in Trinidad and Tobago is adequate".

Goddard revealed that certain Government minis ries would be involved, for part of their exercise was to work out what was the best approach to subven -

Discussion

The Commission, he said, would deal generally with the organisation and administration of sport.

A long discussion of vhether a Government appointed committee had the ower to interfere with the **TTOA** without trangressing the creed of the World Olympics then followed between Press and the Commission members.

Mr. Justice Narine however explained that his Commission had the power to enquire into sports and make recommendations: his was

government-appointed commission to serve the public.

Justice Narine said if he had to call on the TTOA or any such body to give evidence before the commission he would do so. He would not interfere with the TTOA more than: "How things were going?. How well?. How badly?."

Then discussions reverted to the National Sports Council, at which stage Administrative Officer in the Prime Minister's Office Ainsley Tim Pow, membersecretary of the Commission explained that he would have to go to Cabinet again to extend the NSC's term of office in order to retain its status.

The Administrative secretary said he did so, not as member-secretary of the Commission, but "while I am wearing the other hat."

Justice Narine said that his Commission will be hearing evidence from 50 persons and associations every Friday (1-4 p.m.) and Saturday (9 - a.m. to noon) he planned to wind up the enquiry by the end of June, exactly a year after the commission was set up.
