Eulogy, 17 September 2018

"So deep is our sorrow, so great is our loss that we know that God is weeping" and today we are gathered here to pay our respect and celebrate the life of Mrs. Carlene Haynes Griffith. It is indeed an honour for me to pay tribute to Carlene - a friend, colleague, administrator, wife, mother, sister and daughter. In whatever role we knew her, from whatever vantage point, she stood apart as someone special!

Carlene was committed to family and the sport of track and field athletics. Served on the executive then turned Board as treasurer for the past 17 years. She was passionate about enabling the administration of the sport to become better accountable to our stakeholders by continuously completing and providing annual audited statements of the association in a timely manner, a feat never before accomplished prior to my tenure. This achievement was a major cause for our organization to earn the respect of our sponsors as well as winning the annual First Citizens Foundation "Association of the Year" award on six (6) occasions. She supported our transformational agenda in administering the sport as a business. I know that the association can get another treasurer but not another Carlene.

She is one person who is genuinely passionate about her work and extremely ambitious. Beyond work, Carlene is someone with a strong sense of social responsibility and is a very humane and sensitive person. I have known her to be a pleasant, well-mannered and optimistic young woman with a conscientious approach to work and an exuberant outlook on life."
